Deposit and Payment: A \$100 per person deposit plus your optional insurance payment is due at registration. Final payment is due on or before **May 18, 2018**.

Cancellation: All cancellations made before May 18, 2018 are subject to a cancellation handling fee of \$50 per person and any charges imposed by the suppliers providing services for this tour. Cancellations made on or after May 18, 2018 forfeit the original deposit and optional insurance premium is nonrefundable at this time if purchased.

Should it become necessary for you to cancel or interrupt your trip due to a covered reason as stated in your Certificate of Insurance, a claim will be filed with Travel Insured International for those that have purchased the optional insurance.

Optional Travel Protection: The Travel Insured Group Deluxe travel protection plan will be offered to you by World of Travel.
